



Fibra Inn Announces Hotel Indicators for April 2022

Monterrey, Mexico, May 5, 2022 – CIBanco, S.A., Institución de Banca Múltiple, as final and universal beneficiary of Deutsche Bank México, Institución de Banca Múltiple, Fiduciary Division DB/1616 or Fibra Inn (BMV: FINN13) (“Fibra Inn” or the “Company”), an internally-managed Mexican real estate investment trust specialized in the hotel industry serving the traveler with international brands, today announced its operating results for its hotel indicators for **April 2022**.

Same-store sales calculation in April 2022 vs. April 2021 includes 32 hotels in operation out of the 38 properties, considering that:

- Five hotels closed in Silao, Irapuato, Celaya, Coatzacoalcos and the Holiday Inn Coyoacan;
- The JW Marriott Monterrey Valle is excluded, as it was not operating last year.

As of April 30, 2022, Fibra Inn had a total portfolio of 38 properties with 6,442 rooms, 5,653 in operation and 789 remained closed. Fibra Inn participates with a minority investment in two projects under the Hotel Factory model, representing 426 rooms.

Fibra Inn is a Mexican trust formed primarily to acquire, develop, and rent a broad range of hotel properties in Mexico for the business and leisure traveler. The Company has signed franchise, license and brand usage agreements with international hotel brands for the operation of global brands as well as the operation of national brands. These hotels enjoy some of the industry's top loyalty programs. Fibra Inn trades its Real Estate Certificates "CBFIs" on the Mexican Stock Exchange under the ticker symbol "FINN13.
