





Fibra Inn Informs Regarding Changes to its Fiduciary and Common Representative

Monterrey, Mexico, October 28, 2020 – CIBanco, S.A. Institución de Banca Múltiple (as final and universal final beneficiary of Deutsche Bank México, S.A. Institución de Banca Múltiple, Fiduciary Division), as the Fiduciary of the Trust DB/1616 (BMV: FINN13, ADR/OTC: DFBRY) ("Fibra Inn", the "Trust" or "the Company"), the Mexican real estate investment trust internally managed and specialized in the hotel industry serving the traveler with global brands, today announced the following:

Due to the various corporate actions as of October 16, 2020, Deutsche Bank México, S.A., Institución de Banca Múltiple, Fiduciary Division ("Deutsche Bank Mexico") split off and transferred part of its assets, liabilities and equity to a new entity. On the same date, this entity merged with CIBanco, S.A., Institución de Banca Múltiple ("CIBanco"), leaving the latter as the merged company. Therefore, CIBanco acquired the fiduciary portfolio that originally was managed by Deutsche Bank México. In that respect, the merger was registered in the public registry of commerce yesterday, October 27, and taking effect retroactively to October 16, 2020. So, as of today, CIBanco, S.A., Institución de Banca Múltiple (as final and universal final beneficiary of Deutsche Bank México, S.A. Institución de Banca Múltiple, Fiduciary Division), acts as Fibra Inn´s Fiduciary (DB/1616). However, the fiduciary team or human resources responsible for the service provided to Fibra Inn, will continue to be the same.

Likewise, as of October 7, 2020, Masari Casa de Bolsa, S.A., assumed the common representation of the real estate investment certificates FINN13 (the "FINN 13 CBFIs") and, as of October 8, 2020, assumed common representation of the FINN18 ("FINN 18 CBs") certificates, in accordance with the substitution agreement for the common representation dated August 14, 2020 and in response to the resolutions adopted by the Shareholders' Meeting of FINN 13 CBFIs dated May 21, 2020 and the Bondholders' Meeting of FINN18 CBs dated May 21, 2020.
