



Correction Regarding Sale of Tecnológico Norte Hotel

Monterrey, Mexico, October 11, 2019 – Deutsche Bank Mexico, S.A., Banking institution, Trust Division F/1616 or Fibra Inn (BMV: FINN13, ADR OTC: DFBRY) (“Fibra Inn” or “the Company”), a Mexican real estate investment trust internally managed and specialized in the hotel industry serving the business traveler with global brands, clarifies the following:

The two press releases distributed yesterday, which announced the sale of a hotel, both refer to the same property. This property operated under the Tecnológico Norte Hotel brand during the last three months, as such the sale was concluded of this property to a third party.

As such, Fibra Inn reaffirms that this single transaction is aligned with Fibra Inn’s strategy of divestiture of non-strategic assets.

About the Company

Fibra Inn is a Mexican trust formed primarily to acquire, develop and rent a broad range of hotel properties in Mexico aimed at the business traveler. The Company has signed franchise, license and brand usage agreements with international hotel brands for the operation of global brands as well as the operation of national brands. Additionally, the Company has development agreements. These hotels enjoy some of the industry’s top loyalty programs. Fibra Inn trades its Real Estate Certificates (Certificados Bursátiles Fiduciarios Inmobiliarios or “CBFIs”) on the Mexican Stock Exchange under the ticker symbol “FINN13”; its ADRs trade on the OTC market in the U.S. under the ticker symbol “DFBRY”.
