



Fibra Inn Announces Cash Distribution Payment Corresponding to the Third Quarter 2019

Monterrey, Mexico, November 7, 2019 – Deutsche Bank Mexico, S.A., Banking institution, Trust Division F/1616 or Fibra Inn (BMV: FINN13, ADR OTC: DFBRY) (“Fibra Inn” or “the Company”), a Mexican real estate investment trust internally managed specializing in the hotel industry serving the traveler with global brands, announced that the Company will execute a cash distribution from the Trust’s capital reimbursement, for the period of July 1, 2019 to September 30, 2019 through a payment, on November 15, 2019, totaling Ps. 31,198,351.62 (thirty-one million one hundred and ninety eight thousand three hundred and fifty one pesos 62 /100 M.N.).

The following are the important dates for this distribution:

- **Ex-dividend date** November 13, 2019
- **Record date** November 14, 2019
- **Payment date** November 15, 2019

The CBFi distribution fully stems from the capital reimbursement, as follows:

Total amount to be distributed per CBFi:	Ps. 0.0631
Implied Value of the CBFi:	Ps. 17.52

In accordance to current tax laws applicable to Fibra Inn, when the fiduciary delivers CBFi holders an amount greater than the taxable income for the period generated by the trustee assets, the difference shall be considered a capital reimbursement and will lower the proven acquisition cost of the certificates held by those receiving it. The capital reimbursement will not generate a tax withholding for Fibra Inn’s investors.

About the Company

Fibra Inn is a Mexican trust formed primarily to acquire, develop and rent a broad range of hotel properties in Mexico for the business and leisure traveler. The Company has signed franchise, license and brand usage agreements with international hotel brands for the operation of global brands as well as the operation of national brands. These hotels enjoy some of the industry’s top loyalty programs. Fibra Inn trades its Real Estate Certificates (Certificados Bursátiles Fiduciarios Inmobiliarios or “CBFIs”) on the Mexican Stock Exchange under the ticker symbol “FINN13”; its ADRs trade on the OTC market in the U.S. under the ticker symbol “DFBRY”.
